#### A note from the Treasurer- Dan Wilson

The tax-exempt status of 501(c)(3) has had a positive impact on the generous donations from the Stalnaker cousins to the Society. **THANKS TO JOHN BURDIS AND JUDGE CELA BURGE** of Cape Charles, VA.

A special letter is sent for each donation for the generous donor to use at tax preparation time.

Dues are used to support the History Day, Annual Meeting & Reunion and for the publishing and mailings of the newsletters and Holiday Cards.

Generous donations are used for the maintenance of the cabin and cemetery.

We have established a permanent improvement fund (a memorial fund). We have had several relatives pass this year and the immediate relatives sent in monies in their memory.

We will be sharing these donations at the 2022 reunion for all to see the impact of these donations.

Last year the donation of \$5000 by Cindi (Stalnaker) Reece was recognized. Thank You!

President, Barry Stalnaker gave \$1000 in 2021. Thank You!

Secretary, Sandy (Stalnaker) Wilson gave \$2350—50<sup>th</sup> Wedding Anniversary donation. Thank You!

The necessary tax forms have been filed with the State of WV (in August each year) and Federal Government (in January each year). The cemetery property taxes were paid.

All bills are paid after approval by the President using the approved budget.

### A note from the Jacob Stalnaker Cabin Manager & Negotiator - Robert Stalnaker

**Darrell Allman and his family (his son and assistant, Jared Allman)** moved to WY. Last year **Jared Allman** replaced rotten boards in the split rail fencing behind the cabin and subscription schoolhouse.

I have made monthly inspections of the cabin and I had the roof evaluated. I have overseen the monthly pest control treatments, the heating and cooling needs of the cabin, and the monitoring of the temperature readings in the log. RCHS mowed the property only one-time last year. I personally climbed onto the roof to assess the damage.

The estimate for the new roof is \$22,000 to \$27,000 (for a longer lasting roof product).

The cabin needs to be power washed, re stained and sealed this year. This needs to be every 5 years.

## **SFA Cabin Update**

#### Robert Stalnaker, VP

As some of you may or may not be aware, when the SFA Cabin was rebuilt back in the late 90's and early 2000's, the original plan was to move it to out to SFA property where the cemetery resides just south of Beverly, WV. At that time, we had a family member who was on the RCHS (Randolph County Historical Society) board and they were looking for a log cabin from the area to use as a showpiece. A deal was worked out to move the SFA cabin to its current location which is located on

RCHS property in town. This was a good thing at the time as we had members on the RCHS board and leveraged the tax-exempt status of RCHS upon which SFA donations were sent through RHS to get the cabin rebuilt.

Ed Stalnaker was instrumental in those early years as the focal point for getting the cabin rebuilt. He was the Project Manager for getting the disassembly completed, the cabin moved and rebuilt at it's current location. He also was our liaison to RCHS. There is a Memorial to Ed's tireless efforts next to the cabin and a tree was planted there as well. A few short years later, Ed and his wife had to move away due to health reasons and during this time, we no longer had SFA members on the RCHS board. Starting in 2009 we started getting indications from the RCHS board that they considered the cabin as RCHS property and there were some meetings between SFA and RCHS and in 2017, one of out family members who was an Attorney at the time (now a Judge) Cela Burge had several meetings with the SFA board and RCHS board and worked up a detailed MOU (Memorandum of Understanding) which was verbally agreed to in 2017 by both parties. This was sent the RCHS for signature, upon which after numerous attempts, they failed to sign.

Our biggest concern was that the Cabin was being neglected from a maintenance perspective and attempts by SFA members to get work completed on the cabin was met with out contractors being run off by RCHS members and any conversations with RCHS turned into heated conversations. Last year (2021) right before our family reunion, the RCHS board sent us a MOU which was drastically different from the one Cela had spent numerous hours working on and most of the conditions set forth in their copy were not agreeable to the SFA family and board members, so during our annual meeting, we opted to absolve our relationship with RCHS. Our agreed upon options were to:

- **1.** Purchase the property upon which the cabin resides or
- **2.** Relocate the cabin to where we originally wanted it on the SFA property with the cemetery

In mid-August of 2021, I submitted a fair market offer via a local attorney to RCHS to purchase the property. About this same time, I went out to investigate the state of the Cabin as I had taken over the Maintenance responsibilities and based on some input regarding the roof, I inspected the roof and found that it was in a sad state (Cedar Shake Shingles which must be pressured washed and sealed periodically which obviously hadn't been taken maintained). The roof needs to be replaced and started getting quotes.

At the end of September, we received a reply from RCHS via their Attorney that they refused to sale the land and further claimed that they "owned" the Cabin warning us about not doing anything to the cabin without contacting them first. Based on this, the SFA Board opted to get a Real Estate Litigation Attorney involved and in early November we started discussions with Rick Dorsey to represent us. The first step was to conduct a Mediation Meeting with all parties with the Mediator being Tom Steele in Clarksburg, WV, and the date was set for today May 13, 2022, at 11am.

Dan and Sandy Wilson, our attorney Rick Dorsey, along with myself met with Tom Steele starting at 11am and our Primary Goal was non-negotiable with that being that the result of this meeting established SFA as the Owner of the SFA Cabin. RCHS was in another Conference room in the same building. The meeting was relatively short as RCHS wanted to claim ownership also and wouldn't budge.

This resulted in leaving the SFA Board with no option to go ahead with proceedings against RCHS. We notified them that we will be removing ALL items in the cabin and moving them to storage and that our attorney will work with their attorney for a voluntary seal up of the cabin preventing anyone from using/accessing it until this matter is resolved. If they fail to voluntarily agree to sealing it up, our attorney will file an injunction to get this enforced.

One of our other major contention points is that RCHS is claiming that they spent in excess of 50K on the cabin, when in fact, most of these monies were Stalnaker Family "Cabin Specific" Donations sent through RCHS to leverage tax exempt status.

We are hoping that by locking them out of the cabin and the threat of Forensic Accounting investigations will get them back to the table and help them realize the errors of their ways.

As a result of the outcome today, Dan will be setting up a special account for "Legal Fees" and I will be donating \$50 from each of my paychecks into this until this issue is resolved. Please consider donating to this account if you can also, any little bit will help!

### A note from the Old Stalnaker Cemetery Manager- Delores (Stalnaker) Bragg

Our landscaper is doing a good job and the cemetery looks great during my weekly inspections. We voted to give him a pay raise for his excellent work. Robert Stalnaker will be putting in a new and wider entrance to the cemetery soon. Damage occurred this past winter to the entrance. Last year we have obtained the cemetery book written by our First Organizer, Odie Velta Nestor Chapman. Now we have the information on the relatives with the last names of Stalnaker, Ball, and Daniels. There are 50 people buried in the cemetery and we published a list with the names of those buried in the cemetery. You can get a copy from the Heritage Library. At this time, we are continuing to work with the US Government and WV Council for Revolutionary Cemeteries to secure the head stones for the Revolutionary War Heroes that are buried in the cemetery. Thanks to everyone that has volunteered to help with the paperwork. Our goal is to have the Old Stalnaker Cemetery recognized as one of the Revolutionary Cemeteries on the National Registry.

"Roger Ryan's brother, Terry was married to Wanda Abruzzino's sister, Hova. Hova was the wife of Cecil Underwood.


